Investment Strategy Discussion/Review: Kitchen shared the recommendations of the Finance Committee.

The recommendations are:

- Diversity among different financial institutions with no more than 50% of BTA assets in one financial institution.
- Limit of 250K give or take 10%, per financial institution, except MI Class..

- Institution selection will be limited to MI Class, West Shore Bank, Huntington Bank, Independent Bank, Fifth Third Bank, 4Front Credit Union, State Savings Bank, First National Bank and Honor Bank..
- Investment selections should have varying term lengths.
- No CD to exceed 23 months.
 Motion by Kitchen to accept this recommendation. Supported by Noah. 6 ayes, 1 abstention, motion carried.
- 10. Named Depostories and Authorized Signatories: Two signatures are required, Current signers are Carland, Hollenbeck, Hunt, Dunne and Board Chair. The Finance Committee recommends the following depositories be available for usage by Management to hold BTA assets: MI Class, West Shore Bank, Huntington Bank, Independent Bank, Fifth Third Bank, 4Front Credit Union, State Savings Bank, First National Bank and Honor Bank. *Motion by Kitchen* to approve depositories and signatories by Kitchen. Supported by Strang. All ayes, *motion carried*.
