3. **Financials & 2019 Budget Review** Continuing to track under budget. Four months into the fiscal year BTA is tracking \$97k under budget. An extra \$56k in tax revenue was received.   - a. **Non-Mandated Drug Free Workplace Policy** This policy may now be discontinued. The policy addresses use of opioids, which are now addressed in the Controlled Substances and Alcohol Misuse Testing Policy per updates by the FTA

  - c. **Password Policy** At the suggestion of both the auditor and our IT person, we have created a Password policy.
  - d. **Controlled Substances and Alcohol Misuse Testing Policy** FTA has sent out an update to this policy so that it now includes opioids. Eric discussed issues with a zero-tolerance policy for medical marijuana yet allowing opioids. Bill will discuss the issue at the upcoming legislative summit next month. *Motion* by Eric support by Josh to recommend the Board table the Controlled Substances and Alcohol Misuse Testing Policy and Non-Mandated Drug Free Workplace Policy until the next meeting.
